- Thursdays from 12 p.m. 4 p.m.



# **Celebrate Black History Month with Yolo County Library**



Yolo County Library is excited to honor Black History Month with a variety of programs and resources for residents of all ages. The national theme for 2022, Black Health and Wellness, aims to uplift the contributions of Black American medical and folk practitioners while addressing systemic health inequities and amplifying opportunities for the holistic betterment of Black wellness.

To pay homage to the connection between this month's observations and the celebration of Emancipation on Juneteenth, the Library's Black History Month banner was created in the form of a traditional story quilt. Each panel of the quilt incorporates iconography important to the historical narrative of captivity and freedom.

"When I reflect on my people's history, I feel like I am handling something biblical. This part of American history is an Exodus story. The use and placement of every symbol could not be arbitrary. I questioned the digital medium I used to create it and I questioned whether it was right to share these symbols because they represent something either spiritual or secretive," says Youth Services Librarian Katrina Laws-Ewald, who designed the story quilt banner.

In alignment with this year's wellness theme, the Library has partnered with the Yolo County's Health and Human Services Agency (HHSA) Cultural Competence Committee to present The Cost of Darkness, the acclaimed documentary series by award-winning author and educator Sandy Holman. The film, which outlines the sociopolitical factors contributing to racial inequity and lays foundations for systemic change, will screen on Wednesday evenings in February from 6 p.m. to 8:30 p.m. Each screening will be followed by a discussion session with the filmmaker.

Further information, including Zoom links to the free event, is available on the Yolo County Library website.

The Library will also highlight its collections of books, audiobooks, and films by Black creators this February. "While there's still much room for improvement, the publishing industry has begun to address its historic exclusion of Black writers," says Collection Development Librarian Jillian Hinchliffe. "As a result, and as a result of continuing efforts to collect materials that uplift and celebrate Black voices, the Library has a wealth of resources to offer the community year-round." Residents can also visit the Library's social media channels every weekday in February to find spotlights on Black wellness resources, books written by Black authors, and notable Black residents of Yolo County past and present, including historical information from the Yolo County Archives and Yolo County Historical Collection.



# Yolo County Library Awarded \$250,000 Mobile Library Services Grant by the California State Library

Through a statewide competitive application process, Yolo County Library was selected by the California State Library as a recipient of the "Stronger Together: Improving Library Access" grant.

This state-funded opportunity will provide a \$250,000 grant to Yolo County Library so it can acquire a community outreach vehicle and offer programs that improve library access and program delivery. Amy McNeely, Ruby Buentello, Lana Harman, Dana Christy and Meredith Beales submitted the successful application.

A mobile library and expanded program delivery will make it possible for more residents in rural and underserved communities to access library services and programs. Specifically, grant funds will be used to purchase an outreach vehicle (likely a sprinter van), a mobile book collection, enhanced Wi-Fi, chromebooks, and maker kits so staff can reach underserved and underrepresented communities in Yolo County. Customers will be able to check out materials (books, DVDs, hotspots, Chromebooks, early learning kits/backpacks), use our Wi-Fi, experiment with our maker kits, sign up for library cards or the summer reading program, learn about literacy services, print/copy/scan/fax documents, obtain government information (voter registration, tax forms, DMV handbooks, etc.), obtain assistance with job applications, and participate in children's programs.

The van will make regular stops in rural underserved areas (Rumsey, Guinda, Brooks, Capay, Madison Migrant Center, Yolo County Housing -Winters, Dunnigan, Zamora), senior living communities in Davis and West Sacramento, and areas in those cities that are physically distant from our existing libraries, such as South Davis, Bryte/Broderick, and Southport. Additionally, the van will be used to promote the summer reading program, adult and family literacy services, and other library programs and services at farmers' markets, fairs/parades, schools, nursery schools/daycare facilities, food bank distributions sites, and Friends of the Library events.

# **City of Davis includes Funding for South Davis Library in DiSC Proposal**

The Davis Innovation and Sustainability Campus (DiSC) 2022 is heading back to the voters as the City Council voted 5-0 to put the measure on the ballot for June 7, 2022. If the measure passes, it could include up to \$2 million in funding for the construction of a South Davis Library facility.

The \$2 million Developer contribution to the South Davis Library is subject to successful annexation of the Project into the City of Davis. The contribution is further subject to final agreement by the County to earmark the funds for construction of the South Davis Library facility within a reasonable timeframe or funds will be redirected to other Davis community priorities.

# **Yolo County American Rescue Plan (ARP) Mini Grants**

The purpose of the Mini Grants program is to allow for localized responses to the COVID19 pandemic and economic recovery programs that are nimble and transformative.

Applications will be accepted from Friday, February 4, 2022, to Thursday, March 31, 2022, at 5:00 pm. Funding requests should range from \$1,000 and \$10,000 but requests outside of the range will still receive consideration.

The Mini Grant funding is an investment of \$250,000 split equally between the five Districts (\$50,000 per District).

The Mini Grant Priority Categories are: Housing and Homelessness; Food Security; Child, Youth and Family; Mental Health; and Community Parks and Facilities. Strategic Plan Implementation: Water/Wastewater Infrastructure; Broadband; Climate Action; Economic Development; and Aging Needs.
