All appropriate sellers are encouraged to participate and will be considered until we are at full. Spaces are first-come-first serve. Your participation is not guaranteed until the application and payment have been received.

Each physical/virtual space is \$60, or \$75 if you also want to have your link included on the website marketplace until January 1, 2023. - Vendor, or their agent, shall not injure, deface, or modify any part of the site property and agrees to hold harmless Yolo County Library, UC Davis or its' agents responsible for any injury or loss of any kind.
