PICTURING YOLO COUNTY OPENS @ THE GIBSON HOUSE

March 6th - June 17th

Opening Thursday, March 6th 4pm to 7pm

In 2023, the Yolo County Historical Collection sent fifteen frames and nine paintings to conservators to be restored. "Picturing Yolo County" features newly restored portraits made by and for Yolo County residents during the late 1800s. These portraits, while similar in style, exemplify the different ways that local artists chose to work within this art form. This exhibition examines Yolo County portraiture through the work of six 19th century local artists: Phoebe Olevia Hodgen, Calthea Campbell Vivian, Clara Brown, Louis Grund Joran, Carrie Blowers and Annie Blowers.

Collections Object Spotlight

Columbia Phonograph Co. Graphophone

Replayable audio is pervasive and an ever-present aspect of our lives. We listen to music, watch videos, and keep track of our schedule with notifications. For how ubiquitous our modern manufactured soundscape is, it's easy to forget there once was a time when audio was a precious luxury. In 1877, Thomas Edison invented the phonograph in 1877, marking the start of a long path of innovation in sound reproduction. It was the first machine that could both record

audio as well as replay the information it stored. However, because the recordings were done on tinfoil sheets, they were prone to damage and could not withstand multiple uses.

This is exactly what inventors Alexander Graham Bell, Charles Sumner Tainter, and Chichester Bell hoped to overcome with the graphophone. Instead of tinfoil, the team opted to record on wax because it was malleable enough for a machine to create grooves in but also sturdy enough to withstand being replayed multiple times. Throughout its 30 years of mainstream use, the graphophone's patent was held by several companies and ultimately became the namesake for the Columbia Phonograph Company's own audio device--the very model being highlighted here. While the graphophone itself may have been short-lived, the Columbia Phonograph Company went on to become a giant of the music industry, known today as Columbia Records.

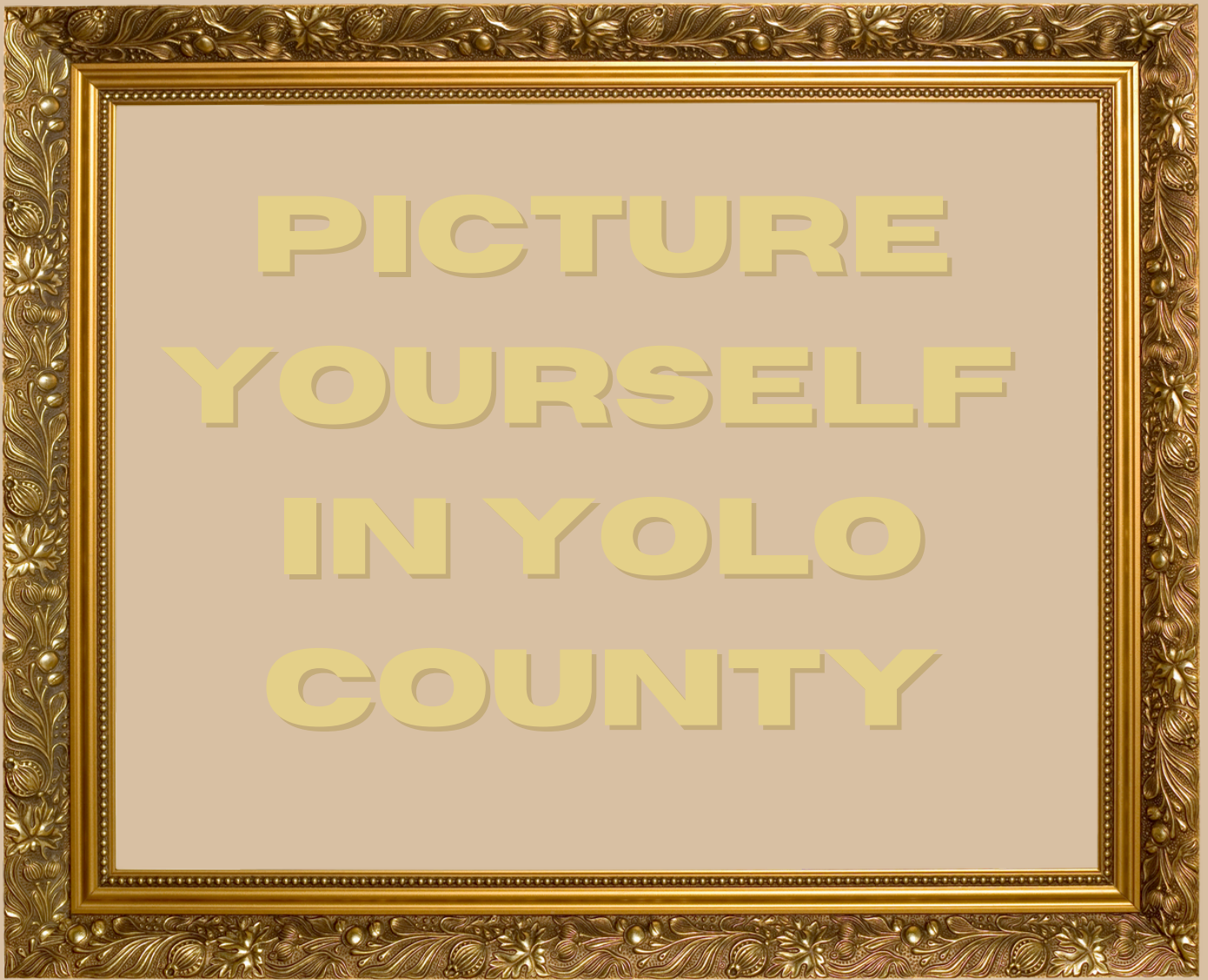
